Missouri River Relief 's mission is to engage individuals and communities along the Missouri River in the exploration, enjoyment, restoration and care of the river through hands-on stewardship, education and recreation.

Missouri River Relief hosted or participated in eleven river clean-ups in 2018, utilizing the help of 1,208 volunteers who helped remove more than 14 tons of trash from the river's environment. 45 miles of river banks were cleaned in communities from Kansas City to St. Louis.

Missouri River Relief hosted numerous education events for students, teachers, young adults and adults throughout the year. We combine place-based education and inquiry-based science for both formal and non-formal educators in professional development programs. In 2018, River Relief worked with 1,980 students and 214 teachers.

Missouri River Relief holds outreach events in order to educate people about our organization and our efforts on the Missouri River. In 2018, Missouri River Relief worked in 23 different communities along the river, gave 38 presentations about the Missouri River, partnered or hosted 29 Big Muddy Speakers Series events across three cities, helped with seven paddling events, conducted 23 educational river trips and worked 13 festivals or booths, introducing more than 6,506 people to the Big Muddy.
