Missouri River Relief 's mission is to engage individuals and communities along the Missouri River in the exploration, enjoyment, restoration and care of the river through hands-on river clean-ups, education programs and recreation.

Missouri River Relief hosted or participated in four river clean-ups in 2020, utilizing the help of 665 volunteers who helped remove more than 31 tons of trash from the river's environment. 112 miles of stream banks were cleaned in communities from Kansas City to St. Louis.

Missouri River Relief hosted numerous education events for students, teachers, young adults and adults throughout the year. We combine place-based education and inquiry-based science for both formal and non-formal educators in professional development programs. In 2020, River Relief worked with 572 students and 50 teachers.

Missouri River Relief holds outreach events in order to educate people about our organization and our efforts on the Missouri River. In 2020, Missouri River Relief gave 62 presentations about the Missouri River, partnered or hosted 15 Big Muddy Speakers Series events, helped with four paddling events, introducing more than 4,081 people to the Big Muddy through each of our different program areas.
